1. **New point (k) inserted at Page 3 –“Minimum Eligibility Criteria / Pre-Qualification Criteria (Invitation For Bid)” as:-**

“The Bidder must furnish Earnest Money Deposit (EMD) of 2% of total value quoted subject to maximum of Rs. 2,00,000 (Rs. Two Lacs) in form of demand draft from any scheduled bank in favour of “Punjab State e-Governance Society” payable at “Chandigarh”, in the envelope containing the Commercial Bid failing which the bill will be rejected.”

2. **Page 3 – 5. Key events & dates are revised as below**

4. Last date of Submission of Bid :	: 06.01.2012 till 12.00 noon
5. Venue, Date and time of Opening of Technical Bids	: 06.01.2012 at 12.30 pm at the pre-intimated venue

3. **Page 3, Clause 4 H** : words “D & E” to be read as “F & G”.
4. **Page 5, Clause 7** : words “90 days” to be read as “120 days”
5. **Page 18, Clause 16.9**: word “reasonable period” is revised as “two weeks”.
6. **Page 27, Annexure II (B), (1) Item : Router, (a) Hardware Architecture- Point 3**: “All the modules, Power supply and fan supporting hot swappable functionality” is revised as “All the modules of Power Supply and fans should have hot swappable functionality”
7. **Page 32, Annexure II (B), (2) Item: Firewall, (e) Protocol point 1.** : : word “PPTV” is revised as “PPTP or equivalent or higher”
8. **Page 32, Annexure II (B), (2) Item : Firewall, (b) Hardware and Interfaces, Point 2** : This point “Should support Optical Fibre” stands deleted.
9. **Page 32, Annexure II (B), (2) Item: Firewall, (e) Protocol point 8.** : words “BGP, DVMRP” is revised as “BGP, DVMRP or equivalent or higher”.
10. **Page 34, Annexure II (B), (2) Item : Firewall , (h) Other Support, Point 13.** : word “SFL” should be read as “SSL”.
11. **Page 21, 3. Warranty**: The sentence “The Warranty should be BACK TO BACK from OEM and valid till three months after expiry of warranty from the date of acceptance along with invocation period of Three months” to be read as “The Warranty should be BACK TO BACK from OEM and valid till expiry of warranty along with invocation period of Three months”

12. **Page 21, Section 4 “Special Terms & Conditions”**

A new clause inserted as

“4. Earnest Money Deposit (EMD):

- a) The earnest money of the unsuccessful bidder shall be refunded after final award of the contract.
- b) EMD of the successful bidder shall be released only after the submission of requisite Performance Bank Guarantee.
- c) The EMD will be forfeited on one or more of the following reasons:-
 - I. Bidder Withdraws its proposal during the bid validity period as specified in the Tender document,
 - II. Bidder does not respond to request for clarifications of the proposal,
 - III. Any attempt by Bidder to hide the facts or misrepresentation or corrupt practices is revealed at any stage,
 - IV. In case of a successful bidder, the said bidder fail to accept the final contract in stipulated time or fail to furnish the Performance Bank Guarantee.”
